

LOCAL LAW 3-2022

A LOCAL LAW PROVIDING FOR THE DESIGNATION OF MINIMUM MAINTENANCE ROADS PURSUANT TO LOCAL LAW 2-2022

Section 1 - LEGISLATIVE AUTHORITY

This local law is enacted pursuant to Section 10 of the New York State Municipal Home Rule Law, including but not limited to Sections 1(ii)a, 1(ii)d, and 4 thereof and is intended to supersede provisions of New York State laws to the extent inconsistent with this local law except to any extent to which the legislature expressly shall have prohibited the adoption of such local law.

SECTION 2 - PURPOSE

The Town of New Lisbon hereby enacts this local law for the purpose of classifying certain town highways or portions thereof as minimum maintenance roads pursuant to Town of New Lisbon Local Law 2-2022.

SECTION 3 - CLASSIFICATION

The procedure set forth in Sections four through six, inclusive, of Town Law 2-2022 having been performed and completed and Town of New Lisbon Town Board Resolution 1-2022, a copy of which is attached hereto and incorporated by reference herein as though fully set forth, having been adopted by the Town Board, the following town highways or portions thereof are hereby classified as Minimum Maintenance Roads in accordance with said Town Law:

1. Stahl Road from Wheat Road to Buck Schoolhouse Road (~0.42 mile)
2. Blue Jay Spur Road (~0.62 mile)
3. Pine Woods Road (~0.44 mile)
4. Barth Road (~0.1 mile)
5. Harrington Road from SH51 toward 204 Harrington Road (~0.39 mile)
6. Mittlesdorf Road from SH51 toward 229 Mittlesdorf Road (~0.60 mile)
7. Pardee Road from CH17 (~0.21 mile)
8. Lena Road from Jones Road toward 447 Lena Road (~1.03 miles)
9. N. Welcome Road from Card Road toward 123 North Welcome Road (~0.32 mile)

Section 8 - Severability

If any clause, sentence, paragraph, section or article of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or article thereof directly involved in the controversy in which such judgment shall have been rendered.

Section 10 - Effective Date

This Law shall take effect upon filing with the New York State Secretary of State.

Resolution No. 1 -2022

Whereas the Town Highway Superintendent has recommended to the Town Board that the following town highways or portions thereof ("Selected Roads") be designated Minimum Maintenance Roads pursuant to Town Law 2-2022:

1. Stahl Road from CH14 to Buck Schoolhouse Road (~0.42 mile);
2. Blue Jay Spur Road (~0.62 mile);
3. Pine Woods Road (~0.44 mile);
4. Barth Road (~0.1 mile);
5. Harrington Road from SH51 to 204 Harrington Road (~0.39 mile);
6. Middlesdorf Road from SH51 to 229 Middlesdorf Road (~0.69 mile);
7. Pardee Road from CH17 (~0.21 mile);
8. Lena Road from Jones Road to 447 Lena Road (~1.03 miles);
9. N. Welcome Road from Card Road to 123 North Welcome Road (~0.32 mile).

Whereas the Town Board has made the following findings with respect to such recommendation:

1. the average daily traffic on the Selected Roads is <50 vehicles per day;
2. the types of vehicles on the Selected Roads are predominantly cars and light trucks and farm vehicles;
3. the owners of parcels abutting the Selected Roads would continue to have reasonable access to their property;
4. the users of the Selected Roads traveling at a reasonable and prudent speed, under the circumstances, would not be placed in a hazardous situation;
5. none of the Selected Roads constitutes a farm access as defined by §10 of Local Law 2-2022;

6. none of the Selected Roads constitutes access to a year-round residence.

Now, therefore, the Town Board of the Town of New Lisbon hereby resolves to approve said recommendation and to set a public hearing for a date no less than 60 days after the date of this resolution on a public law that would classify the Selected Roads as Minimum Maintenance Roads pursuant to Town Law 2-2022.
