

PROPOSED PROTECTIVE COVENANTS

- 1) NO PARCEL SHALL BE FURTHER SUBDIVIDED.
- 2) THE PREMISES CONVEYED SHALL BE USED FOR RESIDENTIAL HOMES.
- 3) COMMERCIAL USE IS PROHIBITED, WITH THE EXCEPTION OF HOME OFFICE, BED AND BREAKFASTS, OR A RESIDENTIAL RENTAL.
- 3) NO PARCEL IS TO BE USED FOR DUMPING OR A JUNKYARD; GRANTEE IS TO KEEP THE LOT IN GOOD AND SANITARY CONDITION
- 4) NO DEVELOPMENT TO TAKE PLACE WITHIN 350 FEET OF THE WETLANDS ON LOTS 9-12. REFER TO THE CURRENT SURVEY FOR WETLAND BOUNDARIES
- 5) IF ANY WHEN ANY PROPERTY OWNER ENGAGES IN CONSTRUCTION ACTIVITY DISTURBING ONE MORE MORE ACRES OF SOIL, THEY MUST DEVELOP A STORMWATER POLLUTION PREVENTION PLAN AND OBTAIN AUTHORIZATION UNDER THE GENERAL PERMIT FOR STORMWATER DISCHARGES FROM CONSTRUCTION ACTIVITIES (CGP)
